

Mersey Crescent - Road surface and markings

We are very grateful for the efforts of Dianne Sakalas at Manchester City Council, for her efforts to help us get the road markings painted at the corner of Craigmore Avnue and Mersey Crescent. Unfortunately for the moment we are unable to get markings at the other end of Craigmore Avenue as Highways UK have currently deemed them unnecessary.

Councillor Richard Kilpatrick met with two council officers on the estate on the 7th February to survey the condition of Mersey Crescent. Both officers agreed that Mersey Crescent was in the worst condition of any road currently not on the agreed programme of work in Didsbury, and they are looking to add the road to next year's programme. We are still awaiting confirmation of this in writing.

Following the public meeting concerning the planning application by Fletcher Moss FC to rebuild the pavilion on Mersey Bank playing fields, councillors Richard Kilpatrick and John Leech applied to the council to push back the consultation deadline. We have since heard from Richard Kilpatrick that this request has not been successful.

There is currently no confirmed date for the application to come before the planning committee. The next two meeting dates for the planning committee are March 14th and April 11th, but neither has a published agenda as of the time of writing.

Richard has met with the planning council to discuss concerns from residents, and councillor David Ellison has met with Fletcher Moss FC to pass on some of these concerns directly. The planning officer has also had a meeting with Fletcher Moss FC to discuss the application.
